The Board of Education of the School District of Papillion La Vista, in the County of Sarpy, in the State of Nebraska, met in open and public session at 6:00 p.m., Monday, February 12, 2024. The meeting was held at the Papillion La Vista Community Schools Administration Office, 420 South Washington Street, Papillion, Nebraska.

Notice of the meeting was provided in advance by publication in the *Sarpy Times*, February 7, 2024. Notice of the meeting was simultaneously given to all members of the Board of Education. Their acknowledgment of receipt of the agenda is maintained at the Papillion La Vista Community Schools Administration Office. The proceedings, hereafter shown, were taken while the convened meeting was open to the attendance of the public.

Call to Order

Board President Marcus Madler called the meeting to order and publicly stated a copy of the Nebraska Open Meetings Law is posted at the entrance to the Board Room. Mr. Madler led the group in the Pledge of Allegiance.

Roll call was taken. All board members were present: Ms. Lisa Wood, Mr. Brian Lodes, Mr. Marcus Madler, Ms. Valerie Fisher, Ms. SuAnn Witt, and Mr. Skip Bailey. There were no comments from the Board or audience.

Communication

There were three public testifiers who addressed the Board, Mr. Darrel E. Lechner Jr., Mr. Aaron Gilliland, and Ms. Lisa Kuechenmeister.

Student Council

Ms. Nova Degbe, representative from Papillion La Vista High School, reported for the Student Council. The school celebrated the Color of Hope February 9th against Millard West raising over \$5,000. All funds raised were donated to the American Cancer Society. The Show Choir and Jazz Band have competed in several competitions and are performing well. The girls' wrestling team had six girls advance to the state tournament and 11 boys are advancing to the state tournament. The Student Council made over 60 blankets for Project Linus. The Dance team competed in Florida at the Nationals. DECA is selling candy grams to raise money for Nationals.

Superintendent's Report

Dr. Rikli provided a report of highlights and activities he has attended this past month. Dr. Rikli thanked the community for attending the meeting and the community members that are watching the meeting on YouTube. Dr. Rikli thanked Ms. Shureen Seery for her leadership at the January 22 board meeting.

The 108th Legislature session is in day 26 of 60. There were over 596 bills submitted. Mr. Tim Gay will be providing an update to the Board.

There are six declared candidates for the upcoming board positions. Incumbents must have their names submitted by March 1, 2024.

Dr. Rikli has attended several advisory meetings including the Student Advisory. The students were asked to provide their reflection on the district's challenges and strengths.

Dr. Rikli was asked to speak at the NE Chambers Association on Collaborative Paths for Workforce Development in Lincoln.

At the next meeting Coach Bill Lynam and PLSHS's student Brennan Heck will be recognized.

The Monarch vs Titan girls' and boys' basketball game was held on February 9.

A motion was made by Mr. Bailey and seconded by Ms. Fisher to approve the Action by Consent Items: The meeting agenda, bills, out of state travel and personnel, and the board meeting minutes of January 22, 2024, as presented. There were no comments from the Board or audience. Roll call vote was taken. Ayes: Lodes, Madler, Fisher. Witt, Bailey, and Wood. Nays: None. The motion carried.

A motion was made by Mr. Lodes and seconded by Mr. Bailey to (1) approve the Guaranteed Maximum Price (GMP) of \$8.058,307 for the Trumble Park renovation and additions and (2) to delegate authority to and authorize, approve the President of the Board of Education, Superintendent of Schools, Assistant Superintendent of Business Services or a designee for the school district to sign, execute and deliver such construction contract, sign and approve any change orders, retain necessary professionals for assistance, pay the contract price, change order increases, and expenses related to the construction project and site preparation work and take all other action necessary to complete any requirements or obligations under the construction project and contract. There were no comments from the Board or audience. Roll call vote was taken. Ayes: Madler, Fisher, Witt, Bailey, Wood, and Lodes. Nays: None. The motion carried.

A motion was made by Mr. Lodes and seconded by Ms. Fisher to (1) approve the Guaranteed Maximum Price (GMP) of \$7,800,451 for the Tara Heights renovation and additions and (2) to delegate authority to and authorize, approve the President of the Board of Education, Superintendent of Schools, Assistant Superintendent of Business Services or a designee for the school district to sign, execute and deliver such construction contract, sign and approve any change orders, retain necessary professionals for assistance, pay the contract price, change order increases, and expenses related to the construction project and site preparation work and take all other action necessary to complete any requirements or obligations under the construction project and contract. There were no comments from the Board or audience. Roll call vote was taken. Ayes: Fisher, Witt, Bailey, Wood, Lodes, and Madler. Nays: None. The motion carried.

Discussion/Information Items

The district's lobbyist, Tim Gay from Catalyst Public Affairs provided an ongoing list of bills that the district will be following during the 108th Legislature session. There were 596 bills introduced for 60-day session. Mr. Gay shared that there are 120 Education bills that the district is watching. Mr. Gay invited the Board to attend the sessions. He would set a time when they could meet with different Senators on the different bills of interest.

Mr. Brett Richards, Assistant Superintendent of Business discussed the Papillion La Vista Community Schools and Springfield Platteview Community Schools developed an agreement in December 2015 that would allow a transfer of specified land boundaries into the Papillion La Vista Community Schools District. The transfers require approval by both School Boards and the State Reorganization Committee. There are two transfers being requested at this time. The Reorganization Plans, once approved by both districts, would provide the necessary documents for the State Reorganization Committee to review and make a recommendation on the transfer of the identified property from the Springfield Platteview Community Schools to the Papillion La Vista Community Schools. The first property is approximately 24.417 acres and generally located on the east side of 72nd St. and Schram Road area. The second property is land owned by Papillion La Vista Community Schools that still needs to be transferred to our school district that would potentially be the home for a new high school in the distant future. This land is approximately 86.92 acres, and the district would pay \$1,200 an acre to Springfield Platteview Community Schools for the transfer of land to help pay for loss of taxes from the past. According to our boundary transfer agreement, current land transfers for which the developer pays Springfield Platteview is \$2,459 per acre in 2023-24. The Board will take action on these two items at the February 26 meeting of the Board.

Dr. Kati Settles, Assistant Superintendent of Human Resources, provided a report on the proposed staffing needs for the 2024-2025 school year. The recommendation from the Administration included increases to the certified staff full time equivalencies (FTEs). Music Certified Teacher @ PLHS – 1.0 FTE. Potential Growth FTEs if needed = 2.0 Special Education and 5.0 General Education. Ms. Fisher appreciated the conservative number requested by Dr. Settles.

Dr. Rikli shared that the Series 2000 Board Policies – Administration is up for annual review. Recommended changes will be discussed at the February 26 board meeting, with possible action at the March 11 meeting. If there are no changes recommended, the Board will acknowledge review of the Series 2000 Board Policies at the February 26 meeting.

Board President Madler reviewed the future board calendar. Board President Madler adjourned the meeting at 7:35p.m.

Stat §§ 79-4,117 to 79-4,129 (the "Act") and other Nebraska laws, by Sarpy County School District 77-0046, a/k/a Springfield Platteview Community Schools, hereinafter referred to as "SP," an accredited Class III School District, under the laws and statutes of the State of Nebraska, and Sarpy County School District 77-0027, a/k/a Papillion La Vista Community Schools, hereinafter referred to as "PL", also an accredited Class III School District, under the laws and statutes of the State of Nebraska, (collectively, both school districts are herein sometimes referred to as the "School Districts"). The School Districts are members of and present the Plan to the Learning Community Coordinating Council (the "Council") for the Learning Community of Douglas and Sarpy Counties (the "LC") for approval and submission on to the State Committee for the Reorganization of School Districts (the "State Committee") for review and action under the Act. Both School Districts have conditionally approved the Plan and hereby request approval from the Council and State Committee according to the Act for submission back to the School Districts for their final approval and implementation by the Sarpy and/or Douglas County Clerk(s). This Plan involves the transfer and attachment to an established district of part of the territory of one or more districts under Neb. Rev. Stat § 79-4,120 and a change in boundaries of the School Districts solely within the LC and no territory is being transferred out of the LC. SP and PL are not part of an affiliation of school districts or an affiliated school system as provided by Nebraska law.
- B. The undersigned School Districts by this Plan, petition, agree, state and represent that it is considered to be in the best interests of SP, PL and the LC, that the boundaries of each of the School Districts be changed in accordance with this Plan and Agreement, and in furtherance thereof, do hereby request the Council, State Committee and County Officials to whom this Plan and Agreement is directed or their successors in interest, to approve same enter an order changing the boundaries of SP and PL, pursuant to Neb. Rev. Stat § 79-4,128, and other Nebraska laws, so as to transfer the following-described territory from SP to PL, such territory (herein sometimes referred to as the "Property") being legally described as follows, to-wit:

A TRACT OF LAND BEING LOTS 5, 8 THROUGH 68, AND OUTLOTS "B" THROUGH "D", SEVENTY TWO PLACE, A SUBDIVISION LOCATED IN PART OF THE NW1/4 OF SECTION 01, TOWNSHIP 13 NORTH, RANGE 12 EAST OF THE 6TH P.M., SARPY COUNTY, NEBRASKA.

C. The terms of this Plan and Agreement and on which the transfer and attachment by a change of boundaries, as described above, is to be made between SP and PL shall be as follows:

1. A DESCRIPTION OF THE PROPOSED BOUNDARIES OF THE REORGANIZED DISTRICTS AND A DESIGNATION OF THE CLASS FOR EACH DISTRICT.

A description of the Property to be transferred from SP to PL is contained above. Both School Districts are Class III school districts. For a description of the boundaries of the reorganized districts see maps referred to in paragraph 5 and attached as Exhibit "1" to this Plan.

2. SUMMARY OF REASONS FOR PROPOSED CHANGE, EXPLANATION OF STATUTORY COMPLIANCE AND STATUTORY ASSURANCE.

The reasons for the proposed transfer and attachment of Property by a change of boundaries pursuant to Neb. Rev. As this Plan only involves such transfer and attachment according to the Act and there is no new district being created, the school boards, school board wards or districts, if any, and classifications of the School Districts involved are unchanged and shall remain the same and the State Committee will not need to determine initial school board districts or wards, or appoint an initial school board.

4. STATEMENT OF FINDINGS ON LOCATION AND UTILIZATION OF SCHOOLS AND TRANSPORTATION

The terms of this Plan involve a transfer and attachment of Property by a change of boundaries pursuant to Neb. Rev. Stat § 79-4,120 as described herein. As this Plan only involves such transfer and attachment according to the Act there is no change with respect to the location of schools, the utilization of existing buildings, the construction of new buildings, or the transportation requirements of the School Districts involved.

5. MAPS SHOWING BOUNDARIES

Maps showing the boundaries of established school districts and the boundaries proposed under this Plan are attached hereto and incorporated herein by this reference as Exhibit "1."

6. OTHER MATTERS

The effective date of the change of boundaries and the transfer of the Property from SP to PL shall be upon final approvals and entry of an order by the appropriate County Officials whose order is necessary to effect the change in boundaries and Property transfer set forth herein, or according to law, whichever occurs later in time. All assets, including budget authority and unbonded liabilities of each School District shall remain the same on such transfer and attachment hereunder and shall not be transferred to PL. The transferred land shall continue to be liable for any bonded indebtedness voted or incurred by SP prior to the boundary change order effective date and such transferred land shall not be liable for any bond indebtedness voted or incurred by PL prior to the effective date of the boundary change order. The transferred land shall be responsible for future bonded indebtedness, if any, voted or incurred by PL after the effective date of the boundary change order. All uncollected real estate taxes due and payable on such transferred land prior to the effective date of the boundary change order shall remain the property of SP. All real estate taxes levied and assessed on such transferred land after the effective date of the boundary change order shall be the property of PL.

Upon completing the transfer the Sarpy and/or Douglas County Clerk(s) shall file the order, certificates or other appropriate notice documents with the Sarpy and/or Douglas County Assessor, Treasurer, the State Committee and all other appropriate county or state officials so that taxing records, voting records, and the like, may be changed to reflect such action, and so that such records and any appropriate maps can be changed accordingly.

The undersigned School Districts hereby certify and agree that the Property described in this Plan is within the parameters and meets all conditions of their ADJUSTMENT OF SCHOOL DISTRICT BOUNDARIES INTERLOCAL AGREEMENT and hereby respectfully initiate and present this Plan, and agree and request that the changes in boundaries as set forth herein.

Background:

The Papillion La Vista Community Schools and Springfield Platteview Community Schools developed an agreement in December 2015 that would allow a transfer of specified land boundaries into the Papillion La Vista Community Schools District. The transfers require approval by both School Boards and the State Reorganization Committee.

The attached Reorganization Plan, once approved by both districts, would provide the necessary documents for the State Reorganization Committee to review and make a recommendation on the transfer of the identified property from the Springfield Platteview Community Schools to the Papillion La Vista Community Schools.

The property is land owned by Papillion La Vista Community Schools that still needs to be transferred to our school district that would potentially be the home for a new high school in the distant future. This land is approximately 86.92 acres, and the district will pay \$1,200 an acre to Springfield Platteview Community Schools for the transfer of land to help pay for loss of taxes from the past. The specific plans for boundary reorganization are attached. According to our boundary transfer agreement, current land transfers for which the developer pays Springfield Platteview is \$2,459 per acre in 2023-24. So, we appreciate the discount in the transfer price for our district from Springfield Platteview for this piece of land.

Recommendation: Motion to approve the ADJUSTMENT OF SCHOOL DISTRICT BOUNDARIES between Springfield Platteview Community Schools and Papillion La Vista Community Schools for the designated land area as presented in the state reorganization packet attached of approximately 86.92 acres and approve an amount of \$104,304 payable to Springfield Platteview Community Schools for this transaction over a period of two years. This transfer is made according to the Interlocal Agreement on file with official district records and the processing of school district approved Reorganization Plan(s) to Transfer and Attach Property by a Change of Boundaries in accordance with the terms and conditions of the Agreement under and pursuant to the Learning Community Reorganization Act (Sections 79-4,117 to 79-4,129) and other Nebraska laws and that the President, Vice President or Superintendent be authorized to execute and deliver the Agreement and implement and administer the transactions thereunder for and on behalf of this school district.

PREPAYMENT AGREEMENT FOR LIENEMANN HOMESTEAD ACRES TRANSFER AND BOUNDARY CHANGE

This Payment Agreement ("Agreement") is entered into on this February 12, 2024 ("Effective Date") by and between Sarpy County School District 77-0046, a/k/a Springfield Platteview Community Schools, a political subdivision under the laws and statutes of the State of Nebraska ("SPCS"), and Sarpy County School District 77-0027, a/k/a Papillion LaVista Community Schools ("PLCS").

RECITALS

- A. PLCS is the legal and record owner or is in the process of acquiring ownership of the real property legally described in <u>Exhibit "A"</u> ("Property"). The Property consists of approximately 86.92 acres, more or less.
- B. The Property is currently attached to, a part of and exists within the boundaries of SPCS.
- C. PLCS has requested that the Property be detached from and transferred out of SPCS' boundaries and attached to and transferred into the boundaries of PLCS.
- D. Pursuant to an interlocal agreement dated December 14, 2015, SPCS and PLCS have agreed to allow the Property to be detached from and transferred out of SPCS' boundaries and attached and transferred into the boundaries of PLCS through a reorganization plan and boundary transfer process as provided under Nebraska law. The above-described interlocal agreement and a draft of the proposed reorganization plan are incorporated into and made a part of this Agreement as if fully set forth herein.
- E. Also pursuant to said interlocal agreement, PLCS has agreed to pay to SPCS for agreeing to allow the property transfer the amount of \$1,200.00 per acre for each acre of the Property that is detached from and transferred out of SPCS' boundaries and attached to and transferred into the boundaries PLCS.

AGREEMENT

In consideration of the foregoing recitals, the covenants contained herein, and other and good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. The total amount to be paid by PLCS to SPCS under this agreement shall be ONE HUNDRED FOUR THOUSAND THREE HUNDRED FOUR AND NO/100THS DOLLARS (\$104,304.00) ("Transfer Payment"), payable as follows. PLCS shall pay the amount of \$52,152.00, representing one-half of the Transfer Payment, to SPCS within five (5) business days of the Effective Date of this Agreement. PLCS shall pay the amount of \$52,152.00, representing the remaining balance of the Transfer Payment, to SPCS by November 1, 2024.
- 2. Upon approval of the reorganization plan by both SPCS and PLCS and receipt of one-half of the Transfer Payment above, SPCS shall file the reorganization plan and proceed

with the transfer process.

3. This Agreement reflects the entire understanding of the parties with respect to the matters addressed herein. This Agreement shall be governed by and construed in accordance with Nebraska law.

C. The terms of this Plan and Agreement and on which the transfer and attachment by a change of boundaries, as described above, is to be made between SP and PL shall be as follows:

1. A DESCRIPTION OF THE PROPOSED BOUNDARIES OF THE REORGANIZED DISTRICTS AND A DESIGNATION OF THE CLASS FOR EACH DISTRICT.

A description of the Property to be transferred from SP to PL is contained above. Both School Districts are Class III school districts. For a description of the boundaries of the reorganized districts see maps referred to in paragraph 5 and attached as Exhibit "1" to this Plan.

2. SUMMARY OF REASONS FOR PROPOSED CHANGE, EXPLANATION OF STATUTORY COMPLIANCE AND STATUTORY ASSURANCE.

The reasons for the proposed transfer and attachment of Property by a change of boundaries pursuant to Neb. Rev. Stat § 79-4,120 as provided herein involve consideration being given to: (1) the educational needs of the learning community, (2) economies in administration costs, (3) the future use of existing satisfactory school buildings, sites, and play fields, (4) the convenience and welfare of pupils, (5) transportation requirements, (6) the equalization of the educational opportunity of pupils, (7) the amount of outstanding indebtedness of each district and proposed disposition thereof, (8) the equitable adjustment of all property, debts, and liabilities among the districts involved, (9) any additional statutory requirements for learning community organization, and (10) any other matters which, in the School Districts judgment, are of importance. This Plan complies with statutory requirements in that no property is leaving the LC and for the reasons stated above. This Plan does not increase the geographic size of any school district that has more than twenty-five thousand students.

3. SUMMARY OF TERMS OF REORGANIZATION.

The terms of this Plan involve a transfer and attachment of Property by a change of boundaries pursuant to Neb. Rev. Stat § 79-4,120 as described herein. As this Plan only involves

such transfer and attachment according to the Act and there is no new district being created, the school boards, school board wards or districts, if any, and classifications of the School Districts involved are unchanged and shall remain the same and the State Committee will not need to determine initial school board districts or wards, or appoint an initial school board.

4. STATEMENT OF FINDINGS ON LOCATION AND UTILIZATION OF SCHOOLS AND TRANSPORTATION

The terms of this Plan involve a transfer and attachment of Property by a change of boundaries pursuant to Neb. Rev. Stat § 79-4,120 as described herein. As this Plan only involves such transfer and attachment according to the Act there is no change with respect to the location of schools, the utilization of existing buildings, the construction of new buildings, or the transportation requirements of the School Districts involved.

5. MAPS SHOWING BOUNDARIES

Maps showing the boundaries of established school districts and the boundaries proposed under this Plan are attached hereto and incorporated herein by this reference as Exhibit "1."

6. OTHER MATTERS

The effective date of the change of boundaries and the transfer of the Property from SP to PL shall be upon final approvals and entry of an order by the appropriate County Officials whose order is necessary to effect the change in boundaries and Property transfer set forth herein, or according to law, whichever occurs later in time. All assets, including budget authority and unbonded liabilities of each School District shall remain the same on such transfer and attachment hereunder and shall not be transferred to PL. The transferred land shall continue to be liable for any bonded indebtedness voted or incurred by SP prior to the boundary change order effective date and such transferred land shall not be liable for any bond indebtedness voted or incurred by PL prior to the effective date of the boundary change order. The transferred land shall be responsible for future bonded indebtedness, if any, voted or incurred by PL after the effective date of the boundary change order. All uncollected real estate taxes due and payable on such transferred land prior to the effective date of the boundary change order shall remain the property of SP. All real estate taxes levied and assessed on such transferred land after the effective date of the boundary change order shall be the property of PL.

Upon completing the transfer the Sarpy and/or Douglas County Clerk(s) shall file the order, certificates or other appropriate notice documents with the Sarpy and/or Douglas County Assessor, Treasurer, the State Committee and all other appropriate county or state officials so that taxing records, voting records, and the like, may be changed to reflect such action, and so that such records and any appropriate maps can be changed accordingly.

The undersigned School Districts hereby certify and agree that the Property described in this Plan is within the parameters and meets all conditions of their ADJUSTMENT OF SCHOOL DISTRICT BOUNDARIES INTERLOCAL AGREEMENT and hereby respectfully initiate and present this Plan, and agree and request that the changes in boundaries as set forth herein.


